
April 2018 Enhancements to the BORN Information System (BIS) Overview and Impact Assessment for Upload Hospitals

 **The next enhancements release of the BORN Information System (BIS) will be live the evening of Wednesday, April 4th, 2018.**

The Hospital Upload File Specification v4.1.1 details the changes for this release and can be found at www.bornontario.ca Follow links for BORN Information System – Data Entry Training – Hospital Upload. Please note there are retired data elements but **no column removals to the record layout** as part of this release. Additionally, there are **new data elements and updates to some data element headers**.

This document provides an overview of the changes as well as additional information on transition timing / release cutover. We have indicated which of the changes can be implemented in advance of the release date and the impact on the site if the changes are not in place by April 4, 2018. Those items that cannot be implemented in the upload file in advance of the April 4th have been **highlighted in yellow**. Hopefully, this will allow you to leverage any available resources in your organization between now and April 2018.

This document is intended as a summary of all the changes in a user-friendly format. Please refer to the Hospital Upload File Specification v4.1.1 (excel file) for full details on the changes including version history, upload reference codes, field types, etc.

EMR screen changes should to be in place by April 1st, 2018 to collect any new data element pick list values for the start of the fiscal year. On the evening of April 4, 2018, the BIS 2018 Enhancements will be released to the production environment and the upload will support the changes (e.g., new values, validations).
